The Regular Meeting of the Hall County Airport Authority (HCAA) Board was held at Home Federal Bank located at 3311 Stolley Park Road, Grand Island, Nebraska 68803 on October 8, 2014. Mr. Olson reported on the legislative issues conveyed from the Rural Air Service Alliance (RASA). Last week the Department of Transportation (DOT) finalized the Enforcement Policy regarding the \$200 per passenger subsidy cap. All communities within 210 miles of the nearest large or medium hub airport receiving subsidized air service under the Essential Air Service (EAS) program have until September 30, 2015, based on data from October 1, 2014, through September 30, 2015, to ensure compliance with the \$200 subsidy cap or face termination of subsidy eligibility. This Enforcement policy was put in place in 1990, and was made permanent in 2000. Even though the policy has rarely been enforced, the DOT is going to start enforcing policy. It will be interesting how this policy will affect Kearney and Scottsbluff airports.

Operations Report by Operations Manager/Security Coordinator Doug Brown:

- Provided Aircraft Rescue and Fire Fighting (ARFF)/Direct Ramp Observation (DRO) for Allegiant flights, Korean Hero Flight departing on September 29th and returning on October 1st, a Charter flight on October 17th, and provided ARFF for American Eagle daily flights.
- Conducted monthly ARFF drills and weekly training held on Part 139 Training, Safety, and Transportation Security Administration procedures.
- Continuous mowing.
- Painted administration offices and installed cabinets in Building 116B (HCAA Administration).
- Installed directional sign on Sky Park Road to Hall County Airport Authority Administration Offices in Building 116B.

- Poured concrete to relocate tenant mail box clusters. Mail boxes will be located on the north end
 of the parking lot near Building A (TSA office).
 - Repaired leaking roof in Building 850 (CMG Enterprise LLC).
 - Repaired overhead door on Building 129 (Maintenance) and Building 853 (Gro-Rite).
 - Repaired outlets and lights in Building 710 (FedEx).
 - Painted Building 90 (Electrical Vault).

- Cleared items out of Building 106 (Fire Station) to make way for tenant Civil Air Patrol to move in.
- Continue with repairs/requirements to Building A (TSA office).
- Replaced gutter on Building 700A (Lamar).
- Relocated HCAA staff parking signs to Building 116B (HCAA Administration).
- Updating Airport Security Plan, Airport Certification Manual, and Airport Emergency Plan.
- Numerous other daily projects completed and scheduled.

Construction & Planning Report. Executive Director reported asbestos abatement in the Administration & Radar buildings needs to be completed, and the Federal Aviation Administration cables relocated before the notice to proceed can be issued for the construction of the passenger terminal. The detention cells east of the west parking lot are holding water so vertical French drains will be installed in both cells to alleviate the problem. The water line and fire hydrant by the 5-Unit hanger have been installed and chlorinated. The first two water tests failed and the city in the process of re-chlorinating and retesting water.

Chief Construction will begin construction of the General Aviation Terminal in March 2015. Chief will install fence and temporary gate around construction site.

CONSIDERATION AND APPROVAL OF RESOLUTION NO. 14-84: EXTENSION AGREEMENT WITH ALOHA INVESTMENTS, LLC.

Motion by Mr. Quandt, second by Mr. Hobbs authorizing the Board Chair to execute Extension Agreement between Hall County Airport Authority and Aloha Investments, LLC, for Restaurant/Lounge Management. The term shall be extended from August 31, 2015 until December 31, 2015 upon the same terms and conditions as set forth in the Agreement. Upon roll call, motion was approved with a 4-0 vote.

CONSIDERATION AND APPROVAL OF RESOLUTION NO. 14-85: LEASE EXTENSION AGREEMENT WITH CMG ENTERPRISE, LLC FOR BUILDING 850 LOCATED AT 1982 CITATION WAY, GRAND ISLAND, NE.

Motion by Mr. Cook, second by Mr. Quandt authorizing the Executive Director to execute Lease Extension Agreement with CMG Enterprise, LLC for Building 850 located at 1982 Citation Way, Grand Island, NE. Lease term is extended for one (1) year effective November 1, 2014 and terminating October 31, 2015. Rent shall be increased to \$1,326.13/month plus \$132.67/month for insurance. Upon roll call, motion was approved with a 4-0 vote.

CONSIDERATION AND APPROVAL OF RESOLUTION NO. 14-86: LEASE EXTENSION AGREEMENT WITH GRO-RITE LLC, FOR BUILDING 847 LOCATED AT 1811 GULF STREAM DRIVE, BUILDING 851 LOCATED AT 1981 GULF STREAM DRIVE, BUILDING 853 LOCATED AT 1925 GULF STREAM DRIVE, AND BUILDING 855 LOCATED AT 1845 GULF STREAM DRIVE, GRAND ISLAND, NE.

Motion by Mr. Cook, second by Mr. Quandt authorizing the Executive Director to execute Lease Extension Agreement with Gro-Rite LLC, for Building 847 located at 1811 Gulf Stream Drive, Building 851 located at 1981 Gulf Stream Drive, Building 853 located at 1925 Gulf Stream Drive, and Building 855 located at 1845 Gulf Stream Drive, Grand Island, NE. Lease term is extended for three (3) years effective December 1, 2014 and terminating November 30, 2017. Rent for Building 847 shall be increased to \$978.50 /month plus \$99.50/month for insurance. Rent for Building 851 shall be increased to \$1,003.32/month plus \$99.50/month for insurance. Rent for Building 853 shall be increased to \$977.06/month plus \$99.50/month for insurance. Rent for Building 855 shall be increased to \$866.75/month plus \$99.50/month for insurance. Upon roll call, motion was approved with a 4-0 vote.

Motion by Mr. Quandt, seconded by Mr. Hobbs authorizing to execute General Services Administration (GSA) Lease Amendment No. 1 to Lease No. GS-06P-90041 for Building 100C located at 3751 Sky Park Road, Grand Island, NE. This lease shall terminate effective September 16, 2014 due to the forced relocation to Building A located at 3565 Sky Park Road, Grand Island, NE under Lease No. GS-06P-LNE41030. No rent shall accrue after the effective date of termination. Upon roll call, motion was approved with a 4-0 vote.

CONSIDERATION AND APPROVAL OF RESOLUTION NO. 14-88: GENERAL SERVICES ADMINISTRATION (GSA) LEASE AMENDMENT NO. 1 TO LEASE NO. GS-06P-LNE41030 FOR BUILDING A LOCATED AT 3565 SKY PARK ROAD, GRAND ISLAND, NE.

Motion by Mr. Cook, second by Mr. Quandt authorizing to execute General Services Administration (GSA) Lease Amendment No. 1 to Lease No. GS-06P-LNE41030 for Building A located at 3565 Sky Park Road, Grand Island, NE. The completion of the IT purchase and installation will be provided by the Lessor at no cost to the Government in accordance with the TSA-GSA IT requirements as in Exhibit A and the TSA IT drawing in Exhibit B. Upon roll call, motion was approved with a 4-0 vote.

CONSIDERATION AND APPROVAL OF RESOLUTION NO. 14-89: GENERAL SERVICES ADMINISTRATION (GSA) LEASE AMENDMENT NO. 2 TO LEASE NO. GS-06P-LNE41030 FOR BUILDING A LOCATED AT 3565 SKY PARK ROAD, GRAND ISLAND, NE.

 Motion by Mr. Quandt, second by Mr. Hobbs authorizing to execute General Services Administration (GSA) Lease Amendment No. 2 to Lease No. GS-06P-LNE41030 for Building A located at 3565 Sky Park Road, Grand Island, NE. Lease Term to have and to hold the said premises with its appurtenances for the term beginning on September 8, 2014 through September 7, 2017, subject to termination and renewal rights as may be hereinafter set forth. Annual rent of \$15,676.80 shall be payable monthly in arrears at \$1,306.40/mo. Upon roll call, motion was approved with a 4-0 vote.

A large American flag was hoisted high on the ladder from the Grand Island Fire truck and served as a backdrop for the water cannon salute staged by the Authority's fire trucks. Mr. Olson commended staff for all their efforts in making this a huge success.

Upon roll call, motion was approved with a 4-0 vote.
